ABM Industries Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff which is effective August 29, 2020. ABM Industries Inc. will no longer be providing staffing services for Flowers Baking Co. of Knoxville resulting in the loss of employment for 136 workers. This company is located at 3100 Northwest Park Drive, Knoxville, TN 37912. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on June 30, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The East Local Workforce Development Area rapid response team, employed by the Mid-Cumberland HRA

has been notified to coordinate services with the employer and affected employees. The East Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
