AlSCO Linen & Uniform Service has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective March 20, 2020. The total number of affected workers is 31. This company is located at 2612 Western Ave., Knoxville, TN 37921. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on March 20, 2020.

The employees at the facility are represented by a collective bargaining agreement. The Eastern Local Workforce Development Area rapid response team, employed by the Mid-Cumberland HGA has been notified to coordinate services with the employer and affected employees. The Eastern Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
