Re: Transition of Kāhi Mōhala

Dear Sirs and Madams:

This is to inform you that Sutter Health Pacific *dba* Kāhi Mōhala (“Employer”) signed an agreement to transfer ownership of Kāhi Mōhala to The Queen’s Health System. We believe that this transition will help connect Kāhi Mōhala’s mental health services with a broader continuum of local care to better serve our community’s whole health.

As part of this transfer, Sutter Health Pacific *dba* Kāhi Mōhala will terminate employment of all employees on October 7, 2024. Some employees may be offered positions at Queen’s, and for those employees we anticipate the first day of employment will be October 8, 2024.

For employees represented by a labor union with an existing collective bargaining agreement, the agreement may provide bumping and/or seniority rights. We have been working with union representatives to review the impact of the closure on affected employees. This has included a discussion of severance benefits.

The termination of employment from Sutter Health Pacific *dba* Kāhi Mōhala is expected to be permanent. In addition, Employer provides the following information to the Department:
