Auto Exchange Dealers of Memphis (ADESA) – East Tennessee has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a layoff that is reasonably expected to be permanent, which is effective October 3, 2020. The company hopes to bring back some, if not all, of the 36 employees. Employees that are not recalled by October 3, 2020, will be terminated. This company is located at 195 Joe McCrary Road, Fall Branch, TN 37656. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on August 4, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northeast Local Workforce Development Area rapid response team, employed by the Alliance for Business and Training has been notified to coordinate services with the employer and affected employees. The Northeast Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
