Avis Budget Group has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a layoff that is permanent for 6 workers and indefinite for 18. The layoff is effective on September 4, 2020. The total number of affected workers is 24. This layoff affects workers at the following locations: 121 Hangar Lane, Nashville, TN 37214, 2055 Alcoa Hwy., Alcoa, TN 37701, 2224 Alcoa Hwy., Alcoa, TN 37701, 1001 Airport Rd., Chattanooga, TN 37421, 1705 Shepard Rd., Chattanooga, TN 37421, and 3593 Airways Blvd., Memphis, TN 38116. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on September 4, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle, East, Greater Memphis, & Southeast Local Workforce Development Area rapid response team, employed by Workforce Essentials, Mid-Cumberland HRA, & Workforce Mid-South has been notified to coordinate services with the employer and affected employees. The Northern Middle, East, Greater Memphis, & Southeast Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
