Chartwell Hospitality has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective March 19, 2020. The total number of affected workers is 830. This company is located at 5000 Meridian Blvd., Ste. 750, Franklin, TN 37067. This layoff affects employees in Sevier, Williamson, and Davidson Counties. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on March 25, 2020.

The employees at the facility are represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by the Mid-Cumberland HRA has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
