Delaware North Companies Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff which is effective March 23, 2020. The company states, "it is reasonably foreseeable that many associates will not return to work within six months." The total number of affected workers is 583. This company is headquartered at 250 Delaware Avenue, Buffalo, NY

14202. The company operates 3 subsidiary locations in Tennessee. The subsidiary locations are as follows: DNC Travel Hospitality Services, 1 Terminal Drive, Ste. 317, Nashville, TN 37214 - Smokey Mountain SS, Inc., 501 Broadway, Nashville, TN 37203 - Memphis Sportsservice Inc., 200 Union Avenue, Memphis, TN 38103. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on July 7, 2020.

Some employees at the facilities are represented by a collective bargaining agreement. The Northern Middle & Greater Memphis Local Workforce Development Area rapid response team, employed by Workforce Essentials & the Workforce Investment Network has been notified to coordinate services with the employer and affected employees. The Northern Middle & Greater Memphis Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
