EnTrans International, LLC dba Athens Trailer Operations has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective April 12, 2020, through April 25, 2020. The total number of affected workers is 299. This company is located at 1125 Congress Parkway N., Athens, TN 37303. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 7, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Southeast Local Workforce Development Area rapid response team, employed by the Mid-Cumberland HRA has been notified to coordinate services with the employer and affected employees. The Southeast Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
