Hutton Hotel has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff that is commencing from May 29, 2020, with all layoffs completed by June 7, 2020. The total number of affected workers is 137. This company is located at 1808 West End Ave., Nashville, TN 37203. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on May 29, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and affected employees. The

Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
