Marriott Hotel Services dba Meadowview Conference Resort & Convention Center has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a layoff. This layoff was initially intended to be temporary. The company now states, "it is reasonably foreseeable that these temporary actions may extend beyond six months." The layoffs began on March 17, 2020. The total number of affected workers is 164. This company is located at 1901 Meadowview Pkwy., Kingsport, TN 37660. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on June 8, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The North East Local Workforce Development Area rapid response team, employed by the Alliance for Business and

Training has been notified to coordinate services with the employer and affected employees. The North East Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
