OPG Holdings LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective March 23, 2020. The total number of affected workers is 73. This company's affected locations are 208 Commerce Street, Nashville, TN 37201, and 4111 Charlotte Avenue, Nashville, TN 37209. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 8, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials, has been notified to coordinate services with the employer and affected employees. The Northern Middle
