Olhausen Billiard Manufacturing Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective March 20, 2020, with layoffs continuing through March 27, 2020. The company states "more layoffs may be necessary". The total number of affected workers is 83. This company is located at 1124 Vaughn Parkway Portland, TN 37148. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 8, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle
