SSA Group LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of an indefinite layoff that went into effect March 29, 2020. The total number of affected workers is 23. This company is located at 3777 Nolensville Pike Nashville, TN 37211. The company hopes to reinstate workers to their positions once the closures caused by COVID-19 come to an end, but at this time, they are unable to provide return-to-work dates. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on October 2, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
