Town & Country Grocers of Fredericktown ,Inc has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure which is effective on or before June 26, 2020. The total number of affected workers is 43. This company is located at 1955 St. John's Ave., Dyersburg, TN 38024. This closure is the result of the company selling substantially all of its assets to several purchasers. Some of the purchasing companies have expressed interest of rehiring some of the affected workers. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on May 5, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The North West Local Workforce Development Area rapid response team, employed by the Mid-Cumberland HRA has

been notified to coordinate services with the employer and affected employees. The North West Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
