Under Armour Nashville Distribution has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff which is effective April 12, 2020. The total number of affected workers is 323. This company is located at 13 Athletes Way, Mount Juliet, TN 37122. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 03, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by the Workforce Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
