Re: WARN Notice of Temporary Suspension of Operations at Wailea Golf LLC

To Whom It May Concern,

Please accept this letter as notification that Wailea Golf LLC, 4050 Kalai Waa St., Kihei, HI 96753, temporarily halted its operations at Wailea Golf Gold & Emerald Club, located at 100 Wailea Golf Club Dr, Kihei, HI 96753, Wailea Tennis club, located at 131 Wailea Ike PI, Kihei, HI 96753, and Wailea Blue Course, located at 100 Wailea Ike Dr, Kihei, HI 96753, on March 24, 2020, due to the unforeseen business circumstances caused by the natural disaster and spread of COVID 19, the Governor of Hawaii's declaration of emergency, as well as the recently issued recommendations and/or orders regarding public gatherings by the CDC and various other government agencies and officials.

It is anticipated that this cessation of operations of the business will be temporary however, based on the fluid and rapidly evolving nature of this situation, we are unable to provide a specific date at which we will be able to recommence operations at this time.

We have temporarily ceased operations of the partial location; thus bumping rights exist.

As a result of the temporary cease in operations on March 24, 2020, approximately 160 individuals (including part-time employees) are employed at Wailea Golf Gold & Emerald Club, Wailea Tennis Club, and Wailea Old Blue and 125 individuals will be put into layoff/furlough status. A list of the job titles of the employees who will be affected, and the number of employees with each job title, is attached. Some of the employees are represented by ILWU Local 142, Maui Division, the Division Director of the Union is Roberto Andrion, Jr., located at 896 Lower Main Street, Wailuku, Hawaii 96793.
