To Whom It May Concern:

Due to the sudden economic downturn caused by the COVID-19 pandemic, **Ko'a Kea Operations, LLC** must lay off all of our part-time, on-call and seasonal employees, and place virtually all of our full-time employees in "zero hours" furlough status, at the Ko'a Kea Resort, 2251 Poipu Road, Koloa, Hawaii 96756.

This action commenced on March 23, 2020 and completed by March 31, 2020. Although we hope to resume normal operations at the Resort as soon as possible, the layoff is permanent and the "zero hours" furlough status is temporary but for an indefinite duration. None of the affected employees has bumping rights.

Affected employees include the following:

Front Desk and Guest Services: 28 employees
Housekeeping and Laundry: 38 employees
Food and Beverage: 48 employees
Sales and Marketing: 1 employees
Maintenance and Engineering: 6 employees
Human Resources, Accounting and Administrative: 7 employees
Security: 5 employees
Spa: 16 employees

No union represents the affected employees.

This constitutes notice to you of a "mass layoff" pursuant to the federal Worker Adjustment and Retraining Notification ("WARN") Act (29 U.S.C. § 2101 *et seq.*). Pursuant to 29 U.S.C. § 2101(b)(2)(A), the reduction in the notification period is a result of business circumstances associated with the sudden economic downturn caused by the COVID-19 pandemic that were not reasonably foreseeable at the time that notice would have been required.
