To Whom It May Concern:

This is to inform you that Meadow Gold Dairies Hawaii (Southern Food Group, LLC) plans to affect a closure of the entire facility located at 925 Cedar Street, Honolulu, HI 96814. We are providing this notice as soon as is practicable to comply with the WARN Act. We are also providing this notice to request, on behalf of our workers, any assistance you may provide to help locate employment opportunities in the community.

Due to unforeseeable business circumstances and the attempted sale of this property in bankruptcy/raising of necessary capital, we expect to begin laying off workers starting on 4/15/2020 and for the entire facility to be closed on or about 4/30/2020. We expect the separations to be permanent. Represented employees have certain bumping rights in the applicable collective bargaining agreement, the application of which will be subject to the collective bargaining process with the union. Non-represented employees do not have any bumping rights.
